Dear Sir or Madam:

This letter accompanies a Notice of Change of Ownership/Control submitted electronically in compliance with all applicable provisions of ALA. CODE § 22.21-270 (1975 as amended) and ALA. ADMIN. CODE r. 410-1-7-.04 by Tanner Medical Center Alabama, Inc. in connection with the replacement, relocation, reduction in beds, change of ownership and change of name of Wedowee Hospital, in Wedowee, Randolph County, Alabama. I describe the project in more detail below, but very briefly this project involves the construction of a new replacement hospital in Wedowee, Randolph County, Alabama, which will be owned by the Randolph County Health Care Authority, the same owner as the current Wedowee Hospital facility, which is currently located at 209 Main Street, Wedowee, Randolph County, Alabama, 36278. The newly constructed hospital facility, which will be located at 1032 Main Street South, Wedowee, Randolph County, Alabama, 36278, will replace the current Wedowee Hospital facility and will be operated under the name "Tanner Medical Center - East Alabama." Pursuant to a lease agreement with the Randolph County Health Care Authority, Tanner Medical Center Alabama, Inc. will be the lessee and licensed operator of the newly constructed replacement hospital facility; the lessee and licensed operator of the current Wedowee Hospital facility is the Health Care Authority of the Town of Wedowee, which leases Wedowee Hospital from the Randolph County Health Care Authority. Upon the opening of the newly constructed replacement hospital facility, the current Wedowee Hospital facility will close and the Health Care Authority of the Town of Wedowee's lease for Wedowee Hospital will be terminated. The proposed date of the commencement of the lease between the Randolph County Health Care Authority and Tanner Medical Center Alabama, Inc. is October 4, 2017.

The following is background information on the parties involved and the transaction culminating in the operation of Tanner Medical Center – East Alabama:

The Randolph County Health Care Authority, a health care authority incorporated under the Health Care Authorities Act of 1982, Code of Ala. §§ 22-21-310 <u>et seq</u>. ("Randolph Authority"), owns the facilities and related assets used in the operation of Wedowee Hospital, a 34-bed Medicare-certified Alabama acute care rural hospital located at 209 Main Street, Wedowee, Randolph County, Alabama 36278. The Health Care Authority of the Town of Wedowee, also a health care authority incorporated under the Health Care Authorities Act of 1982 ("Wedowee Authority"), operates Wedowee Hospital under a lease agreement with the Randolph Authority. Tanner Medical Center, Inc. ("Tanner"), a Georgia nonprofit corporation and Internal Revenue Code ("Code") § 501(c)(3) tax exempt organization, currently provides administrative services to the Wedowee Authority to support Wedowee Hospital operations.

Tanner, a regional health system whose principal office is in Carrollton, Georgia, and its affiliate organizations operate two acute care hospitals, one critical access hospital ("CAH"), and one drug abuse treatment center in Georgia, as well as over thirty physician clinics in western Georgia and eastern Alabama, all of which serve residents in the eastern Alabama and western Georgia areas.

In order to ensure the long-term availability of and access to quality health care services to residents in Randolph County, Alabama, the Randolph Authority and the Wedowee Authority expressed their desire to partner with Tanner to jointly develop and construct a new hospital facility in Wedowee, Alabama to replace the current Wedowee Hospital facility. Pursuant to a Joint Development Agreement dated May 11, 2015, the Randolph Authority, the Wedowee Authority, the Randolph County Commission and Tanner agreed on material terms with respect to the development, financing, construction, equipping, licensing and operation of a new replacement hospital. Under the Joint Development Agreement and subsequent definitive agreements arising out of the Joint Development Agreement, the Randolph Authority agreed to construct and finance the new hospital facility. Tanner formed Tanner Medical Center Alabama, Inc., an Alabama nonprofit corporation and a wholly-controlled subsidiary of Tanner ("TMC Alabama"), for the purpose of entering into a lease agreement with the Randolph Authority under which the Randolph Authority will lease to TMC Alabama the new replacement hospital facility and TMC Alabama will be the lessee and licensed operator. TMC Alabama and the Randolph Authority entered into the lease agreement on April 27, 2016, although the lease agreement will not commence until construction of the new replacement facility is complete, a certificate of completion is issued, and all required regulatory licenses, permits, and approvals have been obtained as necessary for TMC

Alabama to operate the new replacement hospital and admit and treat patients. The new replacement hospital facility will undergo a name change to "Tanner Medical Center – East Alabama." The operations of the current Wedowee Hospital facility will transfer to Tanner Medical Center – East Alabama and TMC Alabama will assume Wedowee Hospital's Medicare and Medicaid provider numbers and provider agreements.

Before commencing construction and before the Randolph Authority and TMC Alabama entered into the lease agreement, the Alabama State Health Planning and Development Agency ("SHPDA") issued on February 4, 2016 a Certificate of Need ("CON") to the Randolph Authority approving the construction of the new replacement hospital facility. As part of the CON, the new replacement hospital facility will reduce its licensed beds from thirty-four (34) to fifteen (15) beds. The CON is attached to the email transmitting this letter and the Notice of Change of Ownership/Control.

The parties anticipate that construction of the new replacement hospital facility will be substantially complete in early September and a Certificate of Completion will be issued in September. Again, the lease agreement between the Randolph Authority and TMC Alabama will not commence, and thus the change of ownership/control of Wedowee Hospital will not occur, until construction of the new replacement facility is complete, a certificate of completion has been issued, and all required regulatory licenses, permits, and approvals have been obtained as necessary for TMC Alabama to operate the new replacement hospital and admit and treat patients. Thus, the CON will be "vested" as provided under Ala. Code § 22-21-270(d) and this transaction will not require further certificate of need approval by SHPDA. The proposed date for the commencement of the lease agreement between the Randolph Authority and TMC Alabama is October 4, 2017.





Current Wedowee Hospital Organizational Structure












Tanner Medical Center – East Alabama Organizational Structure Post October 4, 2017

 Tanner Medical Center – East Alabama, to be operated by Tanner Medical Center Alabama, Inc., will be a licensed 15-bed hospital located in the City of Wedowee, Randolph County, Alabama. It is being constructed to serve the healthcare needs of the people of Randolph County and the surrounding area including Southern Cleburne County through the replacement of the current Wedowee Hospital facility with a new hospital facility. It is the goal of Tanner Medical Center Alabama, Inc. to continue to fulfill this mission within the capabilities of the facility and its staff and to do so in a caring and compassionate manner. Tanner Medical Center – East Alabama will serve patients of all ages regardless of national or ethnic origin, economic status, lifestyle, creed or beliefs.

Tanner Medical Center - East Alabama will offer a variety of services which include:

- Inpatient services which includes a Clinical Decision Unit. Hospitalists will provide coverage for our inpatients.
- 24-Hour Emergency Services
- Limited diagnostic imaging services
- Full clinical laboratory services including access to reference Lab services as needed
- Ambulatory Surgery Service
- Infusion Service

- Physical Therapy, Occupational Therapy, Speech Therapy
- Respiratory Therapy
- Limited In-Hospital Pharmacy Service
- Consulting services by Physician Specialists based on medical staff privileges

The services described above are all offered in the current Wedowee Hospital facility but are limited due to lack of resources.

- 2. The proposal does not include the addition of any new beds.
- The new facility will be a 15-bed facility. The proposal does not include the conversion of any beds.
- 4. No stock will be acquired by Tanner Medical Center Alabama, Inc. and the accounts receivable of Wedowee Hospital will stay with the Health Care Authority of the Town of Wedowee d/b/a Wedowee Hospital, the current lessee and operator of Wedowee Hospital. There are a very few minor equipment type items that will transferred to the new replacement hospital facility by the Randolph County Health Care Authority, the owner of both the current Wedowee Hospital facility and the new replacement facility, but the transfer of equipment will be minimal in both number and value.
