**Re: Corporate Reorganization Resulting in Change in Certificate of Need
Holder for Home Health Agencies**

Dear Ms. Norman:

Based on our prior conversation, this letter contains additional information and a description of the transactions which have occurred and will occur in the near future.

We previously notified you of the merger between United Health Group, Inc. (“UnitedHealth”) and Amedisys, Inc. (“Amedisys”). On June 26, 2023, Amedisys signed an Agreement and Plan of Merger with UnitedHealth. The total value of the transaction was \$3.3 billion. On August 14, 2025 (the “Closing Date”), Aurora Holdings Merger Sub Inc. (“Merger Sub”), a UnitedHealth subsidiary created for the purpose of the transaction, merged with and into Amedisys (the “Merger”). The separate corporate existence of Merger Sub ceased, and Amedisys continues as the surviving corporation in the Merger as a wholly-owned subsidiary of UnitedHealth. The result of the Merger is that Amedisys (and by extension the intermediary organizations and HHA) is wholly owned by UnitedHealth. Home health agencies involved in this transaction are listed in the enclosed Appendix A.

We also wish to inform you of a pending transaction involving only the home care agencies listed in Appendix B. On or around September 30, 2025, Amedisys will complete an internal corporate reorganization resulting in an existing Amedisys entity, Amedisys Alabama, LLC, acquiring the assets of the listed agencies. The name and tax ID number of the agencies will change as a result of this transaction, to reflect Amedisys Alabama, LLC as the new owner. The DBA, operations, personnel, and location(s) will remain the same. While this reorganization will result in a new legal entity as the holder of the Certificate of Need, the overall ownership structure will remain unchanged. Please see the enclosed Organizational Chart which reflects the two transactions.

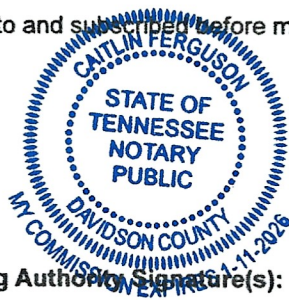

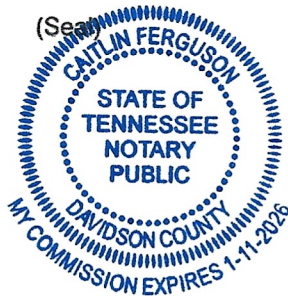
