Please find enclosed the Notice of Change of Ownership/Control form for Knollwood Pointe SCALF, a 32-bed Specialized Care Assisted Living Facility "SCALF" located in Mobile, Alabama. This notice proposes the change of ownership of the facility from 5601 Girby Road Holdings LLC (real property seller) to **Girby Road Realty LLC** (proposed real property buyer and new lessor) and the transfer of operational control from Tarantino Senior Living Communities, LLC (outgoing operator/licensee) to **Knollwood Pointe Memory Care LLC** (proposed facility operator/licensee and new lessee).

- 1. The services provided will be specialty care assisted living services as offered by the previous operator.
- 2. There will be no new beds added.
- 3. There will be no conversion of beds.
- 4. The proposed transaction will be a sale of assets (real property, personal property, equipment, and operational control). The operations will be transferred from Tarantino Senior Living Communities, LLC to Knollwood Pointe Memory Care LLC. The real estate will be transferred from 5601 Girby Road Holdings LLC to Girby Road Realty LLC. The projected yearly operating costs of \$1,050,000 represent amounts which are consistent with current facility operating costs and no substantial increases are expected.




