Ownership or Control for Hospice Agencies**

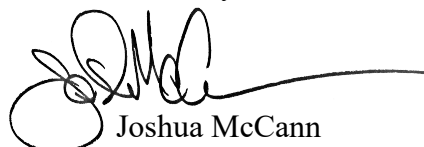
Dear Ms. Norman:

Based on our prior conversation, this letter contains additional information and a description of the transaction which occurred.

We previously notified you of the merger between United Health Group, Inc. (“UnitedHealth”) and Amedisys, Inc. (“Amedisys”). On June 26, 2023, Amedisys signed an Agreement and Plan of Merger with UnitedHealth. The total value of the transaction was \$3.3 billion. On August 14, 2025 (the “Closing Date”), Aurora Holdings Merger Sub Inc. (“Merger Sub”), a UnitedHealth subsidiary created for the purpose of the transaction, merged with and into Amedisys (the “Merger”). The separate corporate existence of Merger Sub ceased, and Amedisys continues as the surviving corporation in the Merger as a wholly-owned subsidiary of UnitedHealth. The result of the Merger is that Amedisys (and by extension the intermediary organizations and hospice agencies) is wholly owned by UnitedHealth. Hospice agencies involved in this transaction are listed in the enclosed Appendix A. Please see the enclosed Organizational Chart which depicts the transaction.

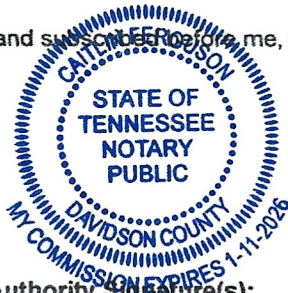

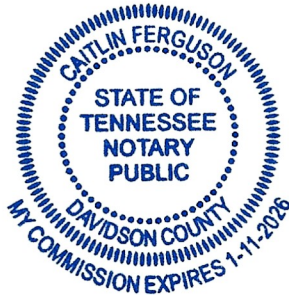

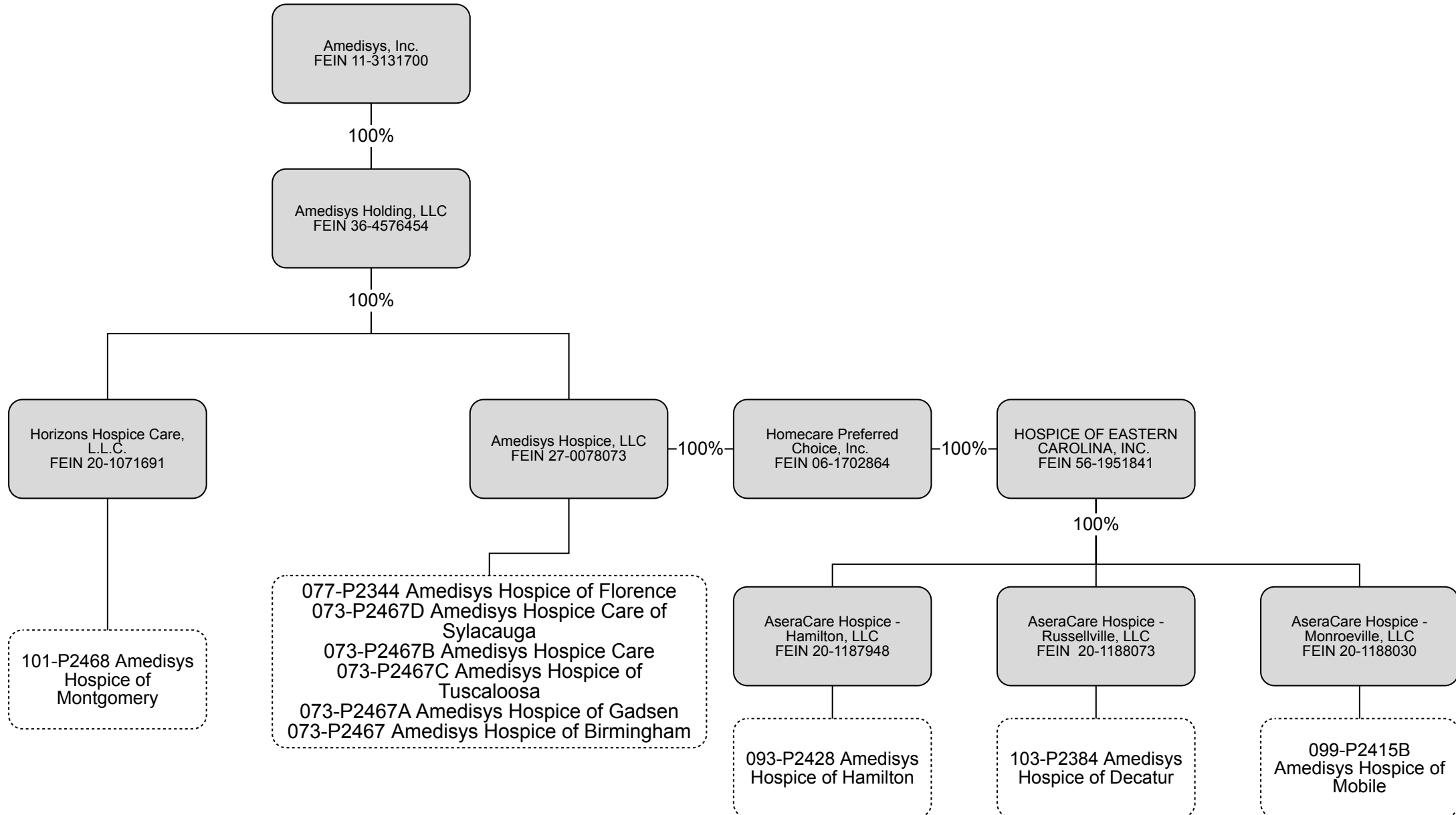
