Change of Ownership Notification

January 8, 2026

- 1.) The SCALF CON was issued to Murray House Assisted Living and licensed by ADPH in December 2025. H&P Holdings Murray House, LLC is the acquiring entity. Crossroads Senior Management, LLC is the operator. Crossroads also manages Haven on Halcyon SCALF (Montgomery). Haven on Halcyon SCALF is also owned by an H&P Holdings entity.
- 2.) The change of ownership will not include the addition of any beds.
- 3.) The proposal will not involve the conversion of beds.
- 4.) The proposal will not involve the acquisition of any stock or assets other than the physical real estate and operating furnishings of the SCALF and ALF owned by the Benevolent Home of the Episcopal Diocese of the Central Gulf Coast, LLC and operated as Murray House Assisted Living.
