On behalf of Prattville Baptist Hospital we are submitting this letter requesting a project modification to CON 2887-Psych, issued on January 6, 2020, for the addition of twenty-two (22) psychiatric beds to the existing Prattville Baptist Hospital in Prattville, Alabama, to initiate a geropsychiatry program.

On June 23, 2021, a new license was granted to Prattville Baptist Hospital by the Alabama State Board of Health and the first psychiatric patient was admitted on June 24, 2021. This project modification is being requested pursuant to Ala. Admin. Code § 410-1-10.03 due to an increase in the cost for the Project of approximately 25%, which is in excess of the 10% approval threshold stated therein. The excess costs relate to an increase in the first year annual operating costs primarily due to an increase in salaries, wages and benefits for clinical providers as a result of the labor shortage from the COVID-19 Pandemic. We have attached an letter from Eric Morgan, CEO of Prattville Baptist Hospital, explaining the increase in salary expenses due to the shortage of clinical providers.

Below is a chart summarizing the changes in the costs associated with this Project compared with the costs as projected in the CON Application:

Dear Ms. Marsal:

The projected cost for salaries, wages and benefits included in the CON Application was calculated prior to the onset of the COVID-19 Pandemic. The CON was issued on January 6, 2020, which was also prior to the COVID-19 Pandemic. Construction was completed on schedule and the first geriatric behavioral health patient was admitted in June 2021. However, at that time and continuing through April 2022, Prattville Baptist Hospital contracted with 29 travel clinicians for the geriatric behavioral health unit due to shortages in the clinical staff from the COVID-19 Pandemic. Payment for the travel clinicians was two to four times greater than the expected costs for full time Baptist staff. This difference in payment accounts for the first year annual operating costs exceeding those projected in the CON Application.
