On behalf of Leoti Dialysis, LLC ("Company") d/b/a Chace Lake Dialysis f/k/a Patton Creek Dialysis we are submitting this letter requesting a Project Modification to CON 2941-ESRD (the "CON"), that was granted to the Company to establish and operate a new fourteen (14) station End Stage Renal Disease (ESRD) facility consisting of thirteen (13) in-center hemodialysis stations and one (l) isolation station, through the relocation of two (2) in-center hemodialysis stations from DVA Renal Healthcare, Inc. d/b/a Birmingham Central Dialysis ("Birmingham Central Dialysis") and the addition of eleven (11) new in-center hemodialysis stations and one (l) isolation station, in Jefferson Countv.
