In accordance with Certificate of Need (CON) Rules and Regulations, **410-1-10-.03** <u>Project</u> <u>Modification After Issuance of Certificate of Need</u>, River Region ALF, LLC respectfully submits the following information in application of a Project Modification to CON 2825-SCALF-EXT:

The above referenced CON was issued on June 5, 2018, for thirty-two (32) specialty care assisted living facility (SCALF) beds as part of a senior living community in Montgomery County. On June 5, 2019, CON 2825-SCALF-EXT was issued necessitated by delays in securing the land purchase agreement. The firm commitment on the project was established on June 5, 2020, through the execution of a construction contract and the final-stage plans and specifications were approved by the Alabama Department of Public Health (ADPH) Technical Services on December 15, 2020. The project property was acquired in November 2021.

The project proceeded, although slowed by supply chain issues as reported in CON Progress Reports. Unfortunately, the global pandemic not only impacted the availability of materials but caused unprecedented escalation in construction costs. As a result, pursuant to CON Rules and Regulations, 410-1-10-.03 Project Modification After Issuance of Certificate of Need, a "change in project" has occurred:

River Region ALF, LLC remains committed to this project and meeting the need for Alzheimer's and other dementia related residents in Montgomery County and the surrounding area. No changes to the original scope and facility program design are being considered at this time. Updated financing has been secured and a management contract with Premier Senior Living, a nationally known operator of senior living communities, has been executed.
