On behalf of Jackson Hospital & Clinic, please accept this letter to request your determination that the proposed addition of one (1) LDRP room is not subject to Certificate of Need review, pursuant to Section 401-1-7-.02 of the Alabama Certificate of Need Program Rules and Regulations. Attached is a check for \$1,000.00 payment of the applicable fee. Please find below information that relates to the project and justifies the non-reviewability status.

Expenditures for the proposed project are as follows:

The project is to add a 15th LDRP room to the 4 North patient wing. Currently, we utilize the 4 West patient wing as overflow for OB/GYN patients, which results in patients and babies being moved multiple times throughout their stay. The addition of a LDRP room on 4 North will improve patient flow and the mom/baby experience. This will not add to our licensed bed total or create any new services. In addition, the hospital will not incur any additional operating expenses as a result of this project. The new LDRP room will be staffed by the current 4 North staff.

Based on the information provided above, we respectfully request your determination that Jackson Hospital & Clinic is not required to obtain a Certificate of Need in order to complete the proposed project.
