Re: Request for Non-Reviewability Determination for Jason Beaver M.D. LLC

Dear Ms. Marsal,

I'm writing pursuant to Ala. Admin. Code r. 410-1-7-.02 seeking a determination that the proposed operations of my practice, Jason Beaver M.D. LLC (the "Practice), will be exempt from Certificate of Need review under the Physician Office Exemption. Offices of private physicians are not "health care facilities" per Ala. Code § 22-21-260(6); further, "health services" do not include "the lawful practice of any profession or vocation conducted independently of a health care facility and in accordance with applicable licensing laws of this state" (Ala. Code § 22-21-2(8)).

I own 100% of the Practice, and no other health care facility or other entity has a financial interest in my practice. The Practice's facilities will be used solely by me, potential future members of my practice, and my employees to perform the proposed services. The proposed services of the Practice are percutaneous dialysis maintenance procedures, as well as upper and lower extremity arterial and venous diagnostic and interventional procedures. No cardiac diagnostic or intervention procedures will be performed. All these proposed procedures will be percutaneous and catheter-based with no incisions. Further, there are no novel procedures being performed, and all the procedures I plan to perform are considered low-risk and minimally invasive. The proposed procedures will be conducted under local anesthesia using light conscious sedation - none of these procedures requires general anesthesia. I am licensed in the state of Alabama and have significant experience with all the procedures I will be performing at the Practice. Further, the Practice has an established emergency care plan to treat any unexpected changes to the patient's status. The Practice will have onsite the following: oxygen, ventilation masks, necessary medications for arrythmias and sedation reversal, and defibrillators. Should a transfer be required for a higher level of care, I maintain admitting privileges at Flowers Hospital for direct admissions, as well as emergency room services.

The service area for my request is Dothan, Alabama.

The proposed operations of the Practice fall within the parameters identified by the Alabama Supreme Court in Ex parte Sacred Heart Health Systems, Inc., 1455 So.3rd 980, 988 (Ala. 2012) to determine whether a proposed medical facility or project qualifies for the physician office exemption from CON review:

- 1. "The proposed services are to be provided, and related equipment used, exclusively by the physicians identified as owners or employees of the physicians' practice for the care of their patients." All procedures will be performed exclusively by owners and employees of the Practice.
- 2. "The proposed services are to be provided, and related equipment used, at any office of such physicians." All procedures will be provided at the location of my practice at 2800 Ross Circle Drive, Suite 2, Dothan Alabama.
- 3. "All patient billings related to such services are through, or expressly on behalf of, the physicians' practice." All patient billing for procedures performed will be done through

and on vental of the Fractice.

4. "The equipment shall not be used for inpatient care, nor by, through, or on behalf of a health care facility." – The facility and its equipment will not be used for inpatient services or by, through, or on behalf of a health care facility. Only for outpatient services.

Approximate costs related to the proposed project are:

Given the above analysis, this request meets the criteria adopted by the Alabama Supreme for application of the Physician Office Exemption. As previously noted, I also confirm that this addition of services within my private physician practice will not exceed any of the certificate of need expenditure thresholds, nor will it constitute a "new institutional health service" under Ala. Code § 22-21-263 because:

- a) no new health care facility or health maintenance organization will be constructed, developed or acquired;
- b) no major medical equipment will be acquired by or on behalf of a health care facility exceeds the statutory purchase price or operating expense thresholds;
- c) no new health care facility beds or stations will be added;
- d) no new health service that is currently offered by the Practice will be provided with the implementation of the procedures described in the document; and
- e) no other event reviewable under the CON law or rules will occur as a result of the implementation of the procedures described in this document.
