The next nine projects were carried over from the March 18, 2020 and April 15, 2020 CONRB meetings which were cancelled.

- A. <u>AL2019-021, Champion Sports Medicine, Vestavia Hills, AL:</u> Proposes to add occupational therapy services to an existing single specialty rehabilitation services facility consisting of physical therapy services in Jefferson County. **Opposition: None**
- **B.** <u>AL2020-001, Crimson Village, LLC, Tuscaloosa, AL:</u> Proposes to expand an existing thirty-two (32) bed specialty care assisted living facility (SCALF) through the conversion of sixteen (16) assisted living beds, resulting in a forty-eight (48) bed SCALF, pursuant to ALA. ADMIN. CODE r. 410-2-4-.04(2)(d)(6)(ii) of the 2014-2017 Alabama State Health Plan. **Opposition: None**
- C. <u>AL2020-004, Geneva County Health Care Authority d/b/a Wiregrass Medical</u> <u>Center, Geneva, AL:</u> Proposes to certify ten (10) existing general acute care beds as ten (10) swing beds, pursuant to ALA. ADMIN. CODE r. 410-2-4-.09 of the 2014-2017 Alabama State Health Plan. **Opposition: None**

- D. <u>AL2020-006, Traditions of Athens SCALF, Athens, AL:</u> Proposes to convert sixteen (16) assisted living facility (ALF) beds to sixteen (16) specialty care assisted living facility (SCALF) beds, pursuant to the adjustment to the *Alabama State Health Plan* approved by Governor Ivey on September 23, 2019. **Opposition: None**
- E. <u>AL2020-007, Limestone Lodge II, Athens, AL:</u> Proposes to convert sixteen (16) assisted living facility (ALF) beds to sixteen (16) specialty care assisted living facility (SCALF) beds, pursuant to the adjustment to the *Alabama State Health Plan* approved by Governor Ivey on September 23, 2019. **Opposition: None**
- F. <u>AL2020-008, Bio-Medical Applications of Alabama, Inc., Montgomery, AL:</u> Proposes to establish a new End Stage Renal Disease (ESRD) Dialysis Treatment Center consisting of twelve (12) in-center hemodialysis stations and one (1) isolation station for a total of thirteen (13) stations. The applicant plans to offer self-dialysis services to enable patients to perform their own hemodialysis treatment in a safe environment that meets all Medicare conditions for coverage for ESRD facilities. **Opposition: None**
- G. <u>AL2020-009, Renal Treatment Centers-Southeast, LP d/b/a Springs Dialysis,</u> <u>Trussville, AL:</u> Proposes to expand by adding two (2) new training stations, to be used alternatively for home hemodialysis training and peritoneal dialysis treatment, to the existing seventeen (17) station ESRD treatment facility. **Opposition: None**
- H. <u>AL2020-010, Birmingham Greystone, LLC d/b/a The Bluffs at Greystone,</u> <u>Hoover, AL:</u> Proposes to establish a thirty-two (32) bed specialty care assisted living facility (SCALF), pursuant to the adjustment to the *Alabama State Health Plan* approved by Governor Ivey on September 23, 2019. **Opposition: None**
- I. <u>AL2020-013, EAMC-Lanier Ambulatory Surgery Center, LLC, Valley, AL:</u> Proposes to operate a multi-specialty ambulatory surgery center (ASC) through the conversion of the existing four (4) operating rooms and one (1) procedure room. **Opposition: None**

J. <u>AL2020-014, Renal Treatment Centers-Southeast, LP d/b/a Jewel Dialysis,</u> <u>Bessemer, AL:</u> Proposes to expand an existing End Stage Renal Disease facility consisting of nine (9) in-center hemodialysis stations and one (1) isolation station through the relocation of sixteen (16) in-center hemodialysis stations from DVA Renal Healthcare, Inc. d/b/a Bessemer Dialysis and the addition of eight (8) new incenter hemodialysis stations, for a total of thirty-four (34) stations consisting of thirty-three (33) in-center hemodialysis stations and one (1) isolation station. **Opposition: None** 

- K. <u>AL2020-015, Baptist Medical Center East, Montgomery, AL:</u> Proposes to add twenty-six (26) acute care beds for the provision of maternity services to the existing licensed bed capacity for a total of one hundred seventy-six (176) general acute care beds pursuant to ALA. ADMIN CODE r. 410-2-4-.02(5), Bed Availability Assurance for Acute Care (Hospitals). **Opposition: None**
- L. <u>AL2020-016, Bio-Medical Applications of Alabama, Inc. d/b/a Fresenius</u> <u>Medical Care Montevallo, Montevallo, AL:</u> Proposes to expand an existing End Stage Renal Disease facility consisting of ten (10) in-center hemodialysis stations through the addition of two (2) in-center hemodialysis stations for a total of twelve (12) stations. **Opposition: None**
